## CRST COVID-19 RESPONSE PLAN

AS OF FRIDAY, SEPTEMBER 18, 2020

The CRST COVID-19 Response Plan on the Cheyenne River Reservation is set by our current risk level. Risk level is determined by three measurable public health criteria: 7-day test positivity, community spread, and hospital capacity. For more details regarding risk level criteria, see page 6. The summary guidance for public advisory, childcare/education systems, healthcare systems, community, and businesses at each risk level is included below. - Level 1** - Post-COVID, establish a new normal
- Level 2** - Low risk and minimal threat to public health
- Level 3** - Moderate risk and medium threat to public health
- Level 4** - High risk and significant threat to public health
- Level 5** - Critical risk and severe threat to public health



### How to use this document:

- Step 1:** Find out what the current level of risk is for the Cheyenne River Reservation by looking on the CRST Coronavirus Website [www.crstcoronavirusupdates.com](http://www.crstcoronavirusupdates.com) or by calling the CRST Command Center.
- Step 2:** Locate the specific topic you need guidance on in the Table of Contents and go to the correct page.
- Step 3:** Find the row for the specific topic you need guidance on.

**DISCLAIMER:** The CRST COVID-19 Response Plan was developed in the absence of any effective treatment for COVID-19. When an effective treatment and/or vaccine becomes available for this disease, the criteria and risk levels detailed in this document will change. If the declared public health emergency ends, this document will no longer be in effect.

## CRITERIA TO DETERMINE RISK LEVEL

The Cheyenne River Sioux Tribe uses three measurable public health criteria to determine the current risk level on the Cheyenne River Reservation. The Public Health Task Force monitors this data and reports to the CRST Chairman and Tribal Council when the risk level has changed. When the Tribe moves to a new level, the CRST Chairman has the discretion to grant a grace period of up to 7 days for organizations to comply with the policy changes for the new level.



### **LEVEL 1 Post-COVID, establish a new normal**

1. 7-day Test Positivity: <1% of tests are positive on CRST OR
2. 7-day Active Case Average: 0
3. Hospital Capacity: Surrounding hospitals accepting patient transfers, and have >50% headroom

### **LEVEL 2 Low risk and minimal threat to public health**

1. 7-day Test Positivity: 1-4.9% of tests are positive on CRST OR
2. 7-day Active Case Average: 1-10
3. Hospital Capacity: Surrounding hospitals accepting patient transfers, and have >50% headroom

### **LEVEL 3 Moderate risk and medium threat to public health**

1. 7-day Test Positivity: 5-9.9% of tests are positive on CRST OR
2. 7-day Active Case Average: 11-25
3. Hospital Capacity: Surrounding hospitals accepting patient transfers, but have <50% headroom

### **LEVEL 4 High risk and significant threat to public health**

1. 7-day Test Positivity: 10-19.9% of tests are positive on CRST OR
2. 7-day Active Case Average: 26-60
3. Hospital Capacity: Surrounding hospitals not accepting patient transfers OR

### **LEVEL 5 Critical risk and severe threat to public health**

1. 7-day Test Positivity: >20% of tests are positive on CRST OR
2. 7-day Active Case Average: 60+
3. Hospital Capacity: Surrounding hospitals not accepting patient transfers OR

On September 17th, the criteria for active cases was changed to a 7-day average. This results in more stable trends that are less sensitive to short-term extreme highs or lows.
